## **Position Description:**

The Full-Time Lead Speech-Language Pathologist (SLP) is responsible for facilitating HARC's clinical programs, including completing the new member intake process and leading small group classes tailored to participant-specific communication and/or cognitive goals. Responsibilities include all aspects of daily program execution: planning and running assigned classes, providing resources for participant engagement, incorporating participant feedback, and communicating with participant families and colleagues. This position also involves participation in training SLP students. As a primary point of contact for HARC participants, the SLP must foster a supportive, energetic, and welcoming atmosphere.

#### **Key Responsibilities:**

- Collaborate with the Executive Director to lead program staff in implementing and maintaining HARC programming based on the needs of current participants.
- Screen and evaluate potential new participants to identify specific communication needs, determine eligibility for the program, and make appropriate program recommendations.
- Interpret new participants' medical history and background information to ensure the best fit within HARC programs.
- Communicate with family members and other support systems to maximize participant outcomes.
- Be proficient in Supported Conversation for Adults (SCA) techniques and foster a positive group environment using the Life Participation Approach to Aphasia (LPAA).
- Develop specific plans for assigned programs, including interventions and materials designed to meet program goals.
- Work with the Executive Director and other SLP staff to gather, enter, and organize outcome data, and report outcome measures.
- Attend team meetings and collaborate with colleagues on clinical program matters and organizational mission.
- Collaborate with referral sources and healthcare colleagues as needed.
- Refer participants for ancillary services as appropriate.
- Participate in the student training program, including interviewing and selecting interns, supervising during sessions, conducting student meetings, and liaising with university personnel as needed.
- Participate in meetings and seminars to maintain HARC's strong reputation.
- Engage in research projects as appropriate and desired.
- Adhere to HARC's policies and procedures.

### Minimum Job Requirements:

- Master's Degree in Speech-Language Pathology.
- Certificate of Clinical Competence from the American Speech-Language-Hearing Association.
- Texas SLP license as required.
- At least 5 years of experience working with adults in a medical rehabilitation setting.
- Expertise in the field of aphasia and proficiency in supported communication techniques.
- Experience with the Life Participation Approach to Aphasia (LPAA) is a plus.
- Experience providing services to an adult neurogenic population.
- A willingness and desire to work in a collaborative, team-based environment.
- Experience supervising graduate externs.

#### **Current Schedule:**

Weekdays Monday-Friday, 8:00 AM - 4:30 PM (Flexible Schedule). Occasional night and weekend events, staff, and board meetings are required.
